Christmas Message

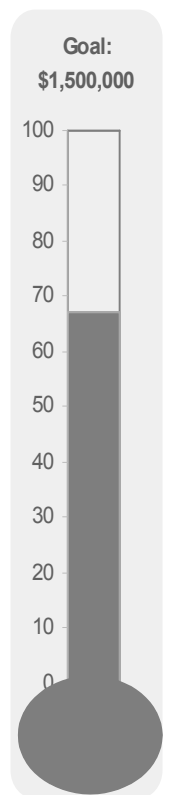

Dear Hawk Alumni and Friends,

As we approach the Christmas Season, I want to take this opportunity to update you on what has been happening at Hudson Catholic during these first few months of this academic year.

Academics: The first quarter ended on a very high academic note. We had more students make the honor roll than over the past few quarters, and we are very proud of that. For those students needing some extra help, our faculty have been working as “departments” after school to meet any student needs. In addition, some of our students, including members of the National Honor Society are acting as “academic mentors,” volunteering their time to work with their classmates to improve their academic performance.

In the fall of 2009, we will be introducing a new Student Information program called “*Power School*.” This system will allow parents Internet access to their child’s academic records, including grades, projects, and teacher comments throughout the academic year. It is my hope that this will strengthen the Parent-Student-School relationship.

Enrollment: We are right now in the midst of decision time for those seeking entry into Catholic High Schools for the 2008-2009 academic year. Mr. Tim Brennan, our Director of Admissions, has put on a “full court press” in getting the word out about HC. Along with the usual newspaper ads, he has developed a video that has aired on cable television stations and has been shown at our open houses. If you would like to view the video you can see it on our website www.hudsoncatholic.org. The two open houses that we have held have seen a greater number of inquiries than in nearly 10 years.

Coed Initiative: When speaking of next year’s enrollment, all of “*The Buzz*” is about Hudson Catholic going co-ed. The first class of “Lady Hawks” is going to be a dynamic addition to the school and the beginning of great new traditions.

Many people ask me “will the bathrooms be ready?”. Certainly, the physical structure will be ready to welcome the Lady Hawks, however, going co-ed involves much more. As I write this, our students are participating in seminars regarding just how the presence of young ladies will change our school culture. These same seminars, being conducted by the schools’ division of Catholic Charities, will also be held for our faculty. Yes,, the entire Hudson Catholic community will be ready!

Board of Consulters: As part of the administrative structure of the school, I have assembled a group of experts in the fields of education, finance, development, and public relations to guide me and the administration in making key decisions as we plan for the future of Hudson Catholic. With this great pool of wisdom and expertise, every decision that needs to be made will be well-thought out and made with the best information possible. I am grateful to the Board members for the time they volunteer to HC to keep us moving in the right direction.

Finances: These are very challenging economic times for us all. I have heard from a number of our parents who have lost jobs or have taken cuts in their pay. I am trying my best in consultation with our finance committee to do what we can while not compromising the financial condition of the school. All of us at Hudson Catholic realize that our tuition cost is a burden for many of our families and we are exploring numerous avenues to increase the financial aid that we can offer to ease that burden.

Our sub-committee on Development continues to pursue Grant opportunities that could help fund some of our academic programs. Fundraising is no longer as simple as having bake sales. Rather it is a complex and sometimes long drawn-out process. We will continue to persevere in pursuing the funding that will sustain Hudson Catholic for many years to come.

School Spirit: One thing Hudson Catholic has no shortage of is Spirit. This is not only found at our athletic venues but in every activity our students participate. Everyone who comes to visit us says they can sense the energy and enthusiasm of our students, faculty, and staff. It is this kind of energy and family spirit that I remember when I was a student here. It is also this spirit that will sustain Hudson Catholic as we move ahead.

So as you can see, the “**State of the School**” is strong! We have much to be thankful for and much to look forward to. It is our Alumni who made this future possible, and I promise to continue to do my best to make HC the “Premiere Catholic Secondary School” in Hudson County.

Although I have been able to extend my thanks to many of you personally throughout the year, it is proper to thank every donor in a formal manner and venue such as this, particularly as the year approaches an end. Not so many months ago, a letter like this seemed implausible, but together, we made it a reality. Hudson Catholic lived beyond June 30th, 2008, and we look forward to graduating our 42nd class this coming June and registering our 46th class in February.

On behalf of our wonderful students, their dedicated families, our valued faculty and our beloved Christian Brothers, I extend my heartfelt thanks and gratitude to acknowledge the generosity of each and every one of our donors – many alumni, as well as friends in the community, and the families, faculty and Christian Brothers.

Your giving to the *Save Our School* Campaign, when Hudson Catholic was threatened with closure, and your continued giving to the renamed *Hudson Catholic Rising* fund, which is aimed at sustaining the school well into the future, has to date resulted in over \$1,000,000 raised.

Indeed, we closed the operating deficit for the current school year, and can do so should the need arise for next year, but we are poised to do so much more. We continue to identify and successfully target additional sources of charitable giving and revenue generation in order to place the school's finances on solid footing into the future; we are readying the plant and facility for conversion to a co-ed institution and to provide for a full slate of girls' athletic teams; and we are building a fund from which we may offer tuition aid for qualified students who otherwise would not be able to attend Hudson Catholic. In fact, we expect to enroll a much larger incoming class than the 90 we will graduate this year.

So many good things are happening as a result of your affinity and dedication to our beloved Hudson Catholic. Remember, though, that a school is not saved in one year, but over the course of many, so please be as generous as you can when you hear from us in 2009 regarding our annual appeal for support for the next school year.

May the Lord sustain all of us through the difficulties of the day and keep Hudson Catholic in our hearts so that today and tomorrow's students, the leaders of the future, may have the same wonderful education and high school experience as we did.
